NOTICE IS HEREBY GIVEN to the legal voters within Fire District No. 3 by the Board of Fire Commissioners of Fire District No. 3 in the Township of Wall in the County of Monmouth, State of New Jersey that at its Annual Fire District election the legal voters of the Fire District shall, in addition to electing commissioner(s) and approving/disapproving the 2013 District Budget, be asked to vote on a proposal to authorize the purchase of a 2000 GPM, 1000 Gallon, Class A engine/pumper and necessary equipment to make the apparatus functionable with funding to commence with the 2013 District budget through capital appropriations or financing of same by the issuance of notes, or bonds, or execute a lease with an option to purchase agreement. The Annual Fire District election will be held on February 16, 2013 and polls will be open from 2:00 p.m. to 9:00 p.m. and shall remain open until 9:00 p.m. and as much longer as may be deemed necessary to permit all the legal voters then present to cast their ballot. The polling place for the Annual Fire District election shall be South Wall Fire-Rescue Station 2, Highway 35 and Church Street, Wall, New Jersey. At said time and place the legal voters shall cast their ballot to elect commissioner(s), approve/disapprove the 2013 District budget and approve/disapprove the following proposal:

PROPOSAL

Shall the Commissioners be authorized to expend an amount not to exceed \$700,000.00 for the purchase of a 2000 GPM, 1000 Gallon, Class A engine/pumper and necessary equipment, with funding to commence with the 2013 District budget through capital appropriations and/or financing of same by the issuance of notes, bonds or execute a lease with an option to purchase agreement.

EXPLANATORY STATEMENT

The Proposed 2000 GPM, 1000 Gallon, Class A engine/pumper will replace a 16 year old engine/pumper which has become outdated, obsolete and cost prohibitive to repair and maintain. The District's retail growth and expansion over the years along with federal and state mandated upgrades has created the need for more technologically advanced firefighting apparatus. The proposed purchase shall meet the needs of the residences, businesses and property owners within the District and legislative mandates. The project as proposed is not anticipated to impact the tax rate.
